Client Agreement and Release of Liability

I hereby release For All Seasons, LLC., its agents, officers, sub-contractors, employees, and potential customers of For All Seasons, LLC. from any and all liabilities, financial and otherwise, for injuries to myself, my pet(s), or any other property of mine, which arise in any way from services and/or products provided by or as a consequence of my association with For All Seasons, LLC.

I agree to assume all liabilities and responsibilities, financial and otherwise, for the behavior and health of my pet(s). In consideration of the services rendered by For All Seasons, LLC. I waive any and all claims, actions, or demands of any nature, foreseen or unforeseen, that I may have against For All Seasons, LLC. relating to the care, control, health, and/or safety of my pet arising during their care.

I authorize For All Seasons, LLC. to do whatever they deem necessary for the safety, health, and well-being of my pet(s) while under the care of For All Seasons, LLC. including seeking professional veterinary treatment for my pet(s).

I understand that For All Seasons, LLC. has the right to refuse service to me and/or my pet(s) at any time for any reason. I understand that if my pet(s) has a history of or repeatedly demonstrates aggression or biting, For All Seasons, LLC. reserves the right to refuse service. I understand that all dog bites will be reported to the local authorities as required by law.

I hereby declare to For All Seasons, LLC. that I am the legal owner of my pet(s); that my pet(s) has not been exposed to distemper, rabies, or parvovirus within the past thirty (30) days, and that my pet(s) has been inoculated as indicated by records presented.

Payment Requirements

I understand that For All Seasons, LLC. operates on a cash or check basis. Payments for services are due in full prior to services being rendered, unless other arrangements have been made in advance. Any additional services that arise during For All Seasons, LLC's care, will be paid in cash when I return.

If I purchase Pet Waste Removal, I understand payment is made for a month in advance and due on the first day of services.

I understand that a \$30.00 handling fee will be applied by For All Seasons, LLC. on returned checks and that all future transactions will require a cash only payment.

Grooming Details

I have given specific grooming information about my dog to For All Seasons, LLC. and understand that, if For All Seasons, LLC. requires any clarification of my grooming requests, they will not groom my dog until they contact me.

I understand that the dematting procedure increases the risk of injury to my dog and will not hold For All Seasons, LLC., its owners or its employees responsible for injury or medical expenses resulting from my dog being dematted. I understand that my dog will only be dematted at my request.

By signing below, I acknowledge that I have read this Service Agreement in its entirety and agree to the terms. This agreement shall be binding for a period of ten (10) years from the date of signature below.
